One Year Extension of County-City 911 Intergovernmental Agreement: Council approved the request to implement a one year extension of the County's intergovernmental agreement with the City of Columbia to provide a joint 911 Communications Center. The one year extension of the current agreement will provide Staff with additional time to explore and negotiate a new intergovernmental agreement. The Committee directed Staff to incorporate all of the applicable County operations (e.g., Sheriff, Coroner, and Fire Departments) into the new agreement, and to ensure that the concerns of the Sheriff's Department are addressed.
