a. Time Warner – Bud Tibshrany presented a symbolic check for \$1,610,458.28 that represented the annual franchise fee paid by Time Warner Cable to Richland County.

- b. Collaborative Economics presented by Mike Briggs of CCEDA Mr. Briggs requested \$17,500 for this fiscal year and \$17,500 for next fiscal year. This funding would support taking inventory of initiatives, conducting a cluster analysis, evaluating the strengths of the University of South Carolina, and creating greater economic development cooperation throughout the region.
- **c. River Alliance** Mike Dawson gave the Council members an update on the Three Rivers Greenway project and thanked them for their support.

- **a. Sheriff to become Homeland Security Officer** Mr. McSwain informed Council that this item came from a Public Safety ad hoc committee and that there is a resolution pending. Tony Mizzell added that the City is joining the County in the 800 mHz project.

- c. Smith made a motion to ask Administration to prepare a fiscal impact statement on the state mandate to care for prisoners. The motion passed.
- d. Mizzell informed Council that there was a press conference on Tuesday, February 18 announcing that USC and Midlands Tech are collaborating on an incubator.
- e. Pearce thanked the Clerk to Council for the new agenda books.
