- Legal: Paid time off for employees to vote in General Election [Third Reading] Approval given to an ordinance amendment that adds general election day as a day on which County employees are granted a two-hour paid leave of absence to vote.
- CASA: full-time grant position for staff attorney [Third Reading] Approval of an ordinance amending the FY 00/01 budget to add one full-time grant position for a staff attorney.
- Participation in Southeast high speed rail study [Third Reading] Approval of a budget amendment in the amount of \$7,500 to help fund an economic impact study to convince Congress and Amtrak to consider the Southeast as the next area for high speed rail travel.
- Ordinance authorizing an expenditure for the USC Arena [Third Reading] Approval of transfer of \$2,500,000 in tourism development fees from the County to the University of South Carolina to assist with construction.
- Detention Center: Privatization of Medical Services [Second Reading] Approval to a budget amendment to add \$308,689.00 from undesignated, unreserved funds to the Detention Center's medical budget to cover the unbudgeted amount of this contract with Prison Health Services.
- Resolution vacating Richland County's property interest in Robertson Creek Road – Approved Resolution relinquishing the County's interest, and removing the road from the County maintenance system.

The vote in favor of adopting the Consent Agenda was unanimous.

THIRD READING

Budget Amendment: Township renovations

Ms. Smith stated she removed this item from the Consent agenda because she thought there was an agreement to have a funding strategy in place before third reading and requested the status of this.

Mr. McSwain stated this information is not ready at this time and requested taking this item up at the next Council meeting. He stated it is not ready because of the holidays and the priority of getting the audit completed.
