## SECOND READING ITEMS

## **General Obligation Bonds for Midlands Technical College**

Ms. Scott moved, seconded by Mr. Mizzell, to give Second Reading approval to an ordinance authorizing the issuance and sale of general obligation bonds in the amount of \$2,000,000.00 and authorizing the issuance and sale of a general obligation bond anticipation note in the amount of \$1,500,000.00 to defray a portion of the cost of the Northeast Technology Center. The vote in favor was unanimous.

# Amendment to the Recreation Commission's Bond Ordinance and Resolution calling for Public Hearing

Ms. Scott moved, seconded by Mr. McEachern, to give Second Reading approval of an ordinance amending the Recreation Commission Bond Ordinance to transfer \$420,000.00 from funds to be used to purchase property to an adult activity center on Parklane Road. The vote in favor was unanimous.

## <u>Conveyance of sewer lines to the City of Columbia for Phase I of</u> <u>the Haskell Heights Sewer project</u>

It was moved and seconded to give Second Reading approval to an ordinance authorizing the execution of a deed to the City for sewer lines located along Robertson Street and Blakely Street in Haskell Heights. ## Quit-Claim Deed to relinquish Richland County's interest in Robertson Creek Road

Ms. Scott moved, seconded by Ms. Tillis, to give this item Second Reading approval.

Mr. Mizzell made a substitute motion, seconded by Mr. Tuten, to defer this item to the next meeting until more information is received.

Ms. Scott objected to the deferment. There was no objection for Ms. Scott to speak to the deferment.

A discussion took place.

After discussion, Ms. Scott withdrew her motion with the consent of Ms. Tillis.

The vote was in favor of the deferment. Mr. Pearce abstained.

## Ordinance amendment to the zoning code (deletion of special exception for commercial uses in rural zones)

Mr. Meetze moved, seconded by Mr. Tuten, to give Second Reading approval to an ordinance deleting commercial uses with up to 5,000 square feet of floor area as a permitted special exception in rural zones. The vote in favor was unanimous.

## **CITIZEN'S INPUT**

Dr. W.L. Boyd expressed dissatisfaction with Genesis Cable Service.

Ms. Scott directed staff to look into this matter and bring a report back to Council.

## **MOTION PERIOD**

Ms. Smith moved to refer the funding request from Eau Claire Health Center to the A&F Committee.

Ms. Smith made a motion to schedule the Salvation Army for a presentation to Council on March 14<sup>th</sup>.

Mr. Meetze requested Mr. McSwain to schedule a trip to Newberry County to look at the road construction performed there.

Mr. Pearce referred the citizen's complaints regarding Genesis Cable to the D&S Committee.
