Subject: Workers Compensation Coverage for Voluntary Constables

A. Purpose

Council is requested to approve workers' compensation coverage in the South Carolina Counties Workers Compensation Trust for state constables voluntarily working for the Richland County Sheriff.

B. Background / Discussion

Anti-terrorism bill H 4416, which was signed by the Governor on July 2, 2002, requires approval and funding by the governing body to have workers' compensation coverage for a county's voluntary constables.

In July 1999 County Council approved workers' compensation coverage for "voluntary deputies." Although the discussion concerned the reserve deputies, a subsequent legal interpretation by the SCCWCT indicated the definition of "voluntary deputies" included state constables. However, the recent legislation places the state constables in a separate category of "voluntary deputies" that requires approval by County Council.

C. Financial Impact

The financial impact associated with this request should be minimal. According to Risk Management, the County should experience one or two workers' compensation claims a year from voluntary constables. The county has already budgeted 02-03 coverage for voluntary deputies, which would have included voluntary constables.

D. Alternatives

- 1. Approve the request to cover voluntary constables for workers' compensation.
- 2. Disapprove the request to cover voluntary deputies for workers' compensation.

E. Recommendation

The Richland County Sheriff's Department recommends that County Council approve workers' compensation coverage for voluntary constables.

Subject: Budget Amendment for Magistrates' New Positions

A. Purpose

This item seeks Council approval of a budget amendment of \$16,109 for Pontiac Magistrate and \$16,109 for Hopkins Magistrate.

B. Background/Discussion

During the budget process for FY 2002/2003, the magistrates requested two new Summary Law Clerk positions. However, these positions were not recommended for funding for the FY 2002/2003 budget year.

These positions are needed to ensure proper filing, tracking, and disposing of all paperwork related to an increase in the workload for both offices last year. These new positions should eliminate the need for overtime and a part-time position.

C. Financial Impact

The impact to the FY 2003 General Fund budget will be an increase of \$32,218. The funding source is use of fund balance. The annualized impact in future years will be \$61,636, increasing approximately six percent annually.

D. Alternatives

- 1. Approve the request for the budget amendment.
- 2. Deny the request for a budget amendment.

Subject: Solid Waste Fees Charged to Municipalities

A. Purpose

Council is requested to consider an amendment to the fee structure in the Solid Waste Department by which municipalities are charged for disposal at the County's C & D landfill.

B. Background / Discussion

As part of the FY 2002-03 Solid Waste budget, the Council, at the staff's recommendation, agreed to begin charging the County's municipalities for solid waste disposal at the County's C & D landfill. In the past, municipalities have been allowed to dispose of waste at the landfill at no cost, with the exception of the City of Columbia, which the Council voted to begin charging for disposal in the year 2000. As a result of the decision to charge the City of Columbia, the City began using a private landfill for its disposal.

The staff's recommendation to begin charging disposal fees to the remaining municipalities was predicated on two issues:

- the revenue generated by the municipal fees was part of the strategy to financially support the operations of the Solid Waste Department, which operates as an enterprise fund and has run a deficit for the last two years; and
- charging the municipalities would be consistent with the Council's action in 2000 to begin charging the City of Columbia for disposal.

Since the implementation of the municipal disposal fee in July 2002, a couple of the municipal representatives have expressed concerns that the smaller municipalities are not as well equipped to pay the fee as the larger municipalities due to budgetary constraints. In response, Council Member Joan Brady has proposed that the disposal fee only apply once a municipality reaches a certain tonnage level. Under this proposal, municipalities could dump up to 5,500 tons at no cost; any tonnage above this amount would be charged at the standard landfill disposal rate, which is \$18.50 per ton.

C. Financial Impact

The municipal tipping fee was estimated to generate \$160,400 in revenue for FY 2002-03. During the previous fiscal year, of the three municipalities that use the County's landfill, Arcadia Lakes, Forest Acres and Irmo, none exceeded the 5,500-ton proposed cap. Establishing the 5,500-ton cap as proposed, therefore, would completely diminish the projected revenue. In this case, alternative revenue sources would have to be identified.

D. Alternatives

- 1. Continue to require that municipalities pay the standard tipping fee for all waste disposed of at the County's C & D landfill.
- 2. Allow each municipality to dispose of up to 5,500 tons at no cost and require the municipality to pay the standard tipping fee of \$18.50 per ton for all tonnage above 5,500.

- 3. Establish a no-charge tonnage cap, as in Alternative 2 above, but at a level other than 5,500 tons.
- 4. Establish a no-charge tonnage cap at \$5,500 (Alternative 2 above), but phase out the cap over the next two years, with the cap reducing to \$2,500 in FY 04 and to \$0 in FY 05. This will allow the municipalities a two-year period in which to make the necessary financial arrangements to begin paying the disposal fee.
- 5. Delete the tipping fees for municipalities altogether.

E. Recommendation

The proposed limit on municipal tipping fees is a policy decision and is, therefore, left to the discretion of the Council. It should be emphasized, however, that the proposed limit would result in a loss of revenue to the Solid Waste Division in the approximate amount of \$160,000, which would have to be made up from other sources.

The approved 2003 budget implemented a multi-year plan to improve the financial position of the fund.

Comments: Approval of alternative # 5 is strongly recommended against. In addition for the finance and "business" reasons stated above is the issue of fairness and consistency. Residents of the City of Columbia pay for their own "C & D" disposal through use of an alternative landfill (as a result of our direction in the past). Also, as part of the FY-03 budget process, the unincorporated curbside collection program also pays of their "C & D" disposal (at the Richland County landfill and the other C & D landfill used). Allowing "free" access to smaller municipalities will undermine the integrity of the Solid Waste Enterprise Fund. Analysis shows that we did not charge for a majority of the landfill space used last FY. We must reverse that trend. The Council should consider that any lost revenue due to a phased approach would have to be made up elsewhere. The Department of Public Works staff recommends Alternative # 1.

Subject: Firefighters' Pay Raise

A. Purpose

Council is requested to approve a budget amendment providing the City of Columbia with \$75,000 for a 2.5% salary increase for all firefighters in Richland County.

B. Background / Discussion

Richland County has an agreement with the City of Columbia to provide fire service to County residents and provides funding to the City of Columbia for this purpose. The Columbia City Council has approved a 2.5% pay increase for all firefighters in the FY 2002/2003 budget. This increase will require a \$75,000 budget amendment. These funds are to be provided by an expected surplus from last fiscal year's Fire Service budget. (Final numbers from this fund have not yet been provided, however.)

C. Financial Impact

This request will require a \$75,000 budget amendment to the City of Columbia. Funds are to be taken from unspent funds from last fiscal year's Fire Service budget. No additional funds should be necessary.

D. Alternatives

- 1. Approve a budget amendment in the amount of \$75,000 to provide firefighters with a 2.5% salary increase, contingent upon funding being provided by a surplus from last year's Fire Service budget.
- 2. Do not approve the budget amendment and return any surplus Fire funds to the General Fund, but further strain the relationship with firefighters.

Subject: One Acre Land Donation

A. Purpose

Council is requested to consider accepting an offered donation of a one-acre piece of property for, according to the giver, "future use as a sheriff substation, fire station and/or ambulance station."

B. Background / Discussion

On July 29th, Joseph Rosen sent a letter to the County Administrator regarding the possible donation to the County of a one-acre piece of property located at the northeast corner of Garners Ferry Road and Cate Road in Richland County. (See the MAP on the following page.) This letter further stipulated that the property "could not be resold without a release from Joseph B. Rosen or his heirs. If the property is not used by Richland County by the date of December 31, 2012, the title would then revert back to Joseph B. Rosen and/or his heirs or assigns."

C. Financial Impact

The acceptance of this property would remove it from the tax rolls. The County Tax Assessor estimates that the county would lose approximately \$60 per year in tax revenue at the current tax rate (if the property remains undeveloped). Additionally, using the property for the purpose for which it is being offered, however, would have a financial impact to the County (i.e, the cost to build a Sheriff's substation, fire station, and/or ambulance station).

D. Alternatives

- 1. Accept the offered donation of a one-acre parcel of property at the corner of Garners Ferry Road and Cate Road.
- 2. Decline the donation of the one-acre parcel of property.

E. Recommendation

This is a policy decision best left to Council's discretion.
